Saint Martin Parish Schools to hold District-Wide Re-Registration of Students

In an effort to ensure that the Saint Martin Parish School District is providing an education to those students who reside within Saint Martin Parish, the Saint Martin Parish School Board will be holding a mandatory re-registration process of students beginning March 14, 2016. **All students currently enrolled in Saint Martin Parish Schools will be required to re-register.**

Parents of students must provide the District with current proof that they permanently reside at an address within a particular school zone.

The following documents are required for re-registration.

Homeowners: Mortgage statement, tax bill, homestead exemption or deed *plus* (1) from group A

Renters: Lease and notarized landlord statement *plus* (1) from group A

- **Group A- Proof of Residency** (All within the last 30 days)
- Cable Bill
- Electricity Bill
- Water Bill

New Registrations

Saint Martin Parish Schools will also conduct District-Wide Registrations for students who are entering Saint Martin Parish Schools for the first time. Parents will be required to provide the zoned school with the following items during registration:
